### 1. Review and discuss items on the agenda for the September 9, 2019 Regular Council meeting.

Assistant City Manager John Pombier discussed item 4-e, **(Dollar-Limit Increase for Year 2 and One-Year Renewal (Year 3) to the Term Contract for Medical Billing Services for the Mesa Fire and Medical Department (Citywide))** on the Regular Council Meeting agenda. He stated the extension is due to a higher volume of calls than anticipated and the cost is covered by the revenue generated from the higher volume of calls. He explained eventually the billing will be done on a daily basis and handled in a business services type relationship.

In response to a question by Councilmember Luna, Mr. Pombier stated this is a specialized skill and there is a person in training but will probably be contracted out in the future.

City Manager Christopher Brady explained during the pilot program staff has been assessing the growth of the program and developing expertise. He added a comparison will be done to verify if outsourcing or in-house billing is more cost effective.

In response to a question from Vice Mayor Freeman, Mr. Pombier verified there is an opt-out clause.
