EXHIBIT A TEMPORARY TURN AROUND EASEMENT LEGAL DESCRIPTION

A portion of land being situated within the Southwest quarter of Section 25, Township 1 South, Range 7 East of the Gila and Salt River Meridian, Maricopa County, Arizona, being more particularly described as follows:

BEGINNING at a found aluminum cap accepted as the West quarter corner of said Section 25, from which a found brass cap flush accepted as the Northwest corner thereof, bears North 00°43′34″ West, 2644.16 feet;

Thence along the East-West Mid-Section line of said Section 25, South 89°40′43″ East, 52.51 feet, to a non-tangent curve, concave northeasterly, having a radius of 20.00 feet, the center of which bears North 88°45′00″ East;

Thence leaving said East-West Mid-Section line and southeasterly along said curve, through a central angle of 73°08′29″, an arc length of 25.53 feet to the beginning of a tangent reverse curve, concave northwesterly, having a radius of 60.00 feet;

Thence southerly and westerly along said curve, through a central angle of 221°08′39″, an arc length of 231.58 feet to a non-tangent line, said line being the West line of said Southwest quarter;

Thence along said West line, North 00°25′03″ West, 109.81 feet to the **POINT OF BEGINNING.**

The above described parcel contains a computed area of 12,237 sq. ft. (0.2809 acres) more or less and being subject to any easements, restrictions, rights-of-way of record or otherwise.

The description shown hereon is not to be used to violate any subdivision regulation of the state, county and/or municipality or any land division restrictions.
