***3-h <u>15-0200</u>** <u>D'Vine Wine Bar & Bistro</u>

A wine bar with a restaurant that serves lunch and dinner is requesting a new Series 12 Restaurant License for Arizona - For Better Business Association LLC, 2837 North Power Road, Suite 101 - Randy Nations, agent. There is currently no existing license at this location. (District 5)

4 Take action on the following contracts:

*4-a <u>15-0163</u> Purchase of Six Replacement Vehicles including Two Light-Duty Extended Cab Pickup Trucks, One Light-Duty Crew Cab Pickup Truck and Three Sport Utility Vehicles for the Fire and Medical Department (Citywide)

This purchase will replace four 1/2-ton extra cab pickup trucks and two vans. The Sport Utility Vehicles will be equipped for emergency response and have the capability to carry emergency medical service equipment in the rear of the vehicle. The replacement vehicles have met established criteria and will be retired and sold at auction.

Fire and Medical and Purchasing recommend authorizing the purchases from contracts with Berge Ford (a Mesa Business), at \$78,859.74, PFVT Motors, Inc., at \$93,907.15 and LSH Lights, at \$16,567.86; for a combined total award of \$189,334.75. This purchase is funded by the Capital-General Fund.

*4-b <u>15-0159</u> Purchase of Three Replacement Light-Duty Animal Control Transport Trucks for the Neighborhood Outreach/Animal Control Department (Citywide)

> This purchase will provide three replacement vehicles to transport domestic animals to support Animal Control's daily operations. The vehicles being replaced have met established criteria and will be retired and sold at auction.

Fleet Services, Neighborhood Outreach/Animal Control and Purchasing recommend authorizing purchase from the lowest, responsive and responsible bidder, Courtesy Chevrolet, at \$163,043.13. This purchase is funded by the Vehicle Replacement Fund.

*4-c <u>15-0166</u> Three-Year Term Contract for Tire Maintenance and Repair Services for the Fleet Services Department (Citywide)

This contract will provide tire maintenance and repair services on approximately 1,600 pieces of equipment maintained by the Fleet Services Department. Work includes providing all labor, equipment, tools, service trucks and services required for inspection, scheduled maintenance and repairs and emergency road calls.

An evaluation committee representing Fleet Services and Purchasing evaluated responses and recommends awarding the contract to the highest scored proposal from Jack's Tire and Oil, LLC, dba Jack's Tire and Oil, at \$497,000.00 annually, based on estimated requirements.

*4-d <u>15-0164</u> Purchase of a Safety Analysis Software Upgrade for the Transportation Department (Sole Source) (Citywide)

Transportation has been using Intersection Magic for safety analysis for several years. An upgraded web-based version of this crash analysis software, Crash Magic Online, is now available with increased functions and analytical abilities. Eight Maricopa Association of Governments agencies, including Mesa, were awarded a federal aid grant to update their crash analysis software.

Transportation and Purchasing recommend authorizing the purchase using the Arizona Department of Transportation contract with the sole source vendor, Pd' Programming, Inc., at \$26,400.00. This purchase is funded: 94.3% (\$23,575.00) by the Federal Highway Administration Grant, 5.7% City match (\$1,425.00) and Tax (\$1,400.00) by the Transportation Department operating budget.

*4-e <u>15-0162</u> Three-Year Term Contract for Concrete Supplies for the Transportation Department (Citywide)

This contract will provide various concrete supplies including tools and equipment used for concrete placement, right-of-way maintenance, and storm drain maintenance for use by Transportation, Field Operations staff.

Transportation and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Border Construction Specialties, at \$31,200.00 annually, based on estimated requirements.

*4-f <u>15-0160</u> Three-Year Term Contract for Weed Control and Landscaping Services for the Water Resources Department (Citywide)

This contract will provide bare ground weed management, minor landscaping including tree and shrub trimming and removal of debris at the Brown Road Water Treatment Plant, Southeast Water Reclamation Plant, Greenfield Water Reclamation Plant and Northwest Water Reclamation Plant.

Water Resources and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Environmental Earthscapes, dba The Groundskeeper, at \$57,120.00 annually, based on estimated requirements.

*4-g <u>15-0158</u> Replacement Purchase of One Medium-Duty Truck equipped with a Telescopic Crane for the Water Resources Department (Citywide)

This purchase will provide one replacement vehicle equipped with a 9-foot service body and crane to support Wastewater Utility's daily operations. The vehicle being replaced has met established criteria and will be retired and sold at auction.

Fleet Services, Water Resources and Purchasing recommend authorizing purchase from the lowest, responsive and responsible bidder, PFVT Motors, Inc., dba Peoria Ford, at \$44,562.44. This purchase is funded by the Utility Replacement Extension and Renewal Fund.

*4-h <u>15-0165</u> Three-Year Term Contract for Water Meters for the Water Resources Department (Citywide)

This contract will provide 3/4", 1", 1.5" and 2" water meters for use at new and replacement residential and commercial locations.

Water Resources and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Zenner USA, at \$1,045,000.00 annually, based on estimated requirements.

*4-i <u>15-0161</u> Falcon Field Airport Terminal Upgrades (District 5)

This project is a comprehensive remodeling and update of the entire Falcon Field Airport terminal building to create a uniquely identifiable gateway to Mesa that is an economically vibrant and functionally efficient multi-use facility serving the tenants, businesses, visitors and general public at one of the top six general aviation airports in the nation.

Recommended award to Builders Guild, Inc. (a Mesa business), in the amount of \$1,868,296.00 based on the GMP proposal of \$1,746,071.00, plus an additional \$122,225.00 (7% allowance for change orders). This project is funded by the FY14/15 Falcon Field Capital Program.

5 Take action on the following resolution:

*5-a <u>15-0150</u> Approving and authorizing the City Manager to enter into a Morris Plaza License Agreement with Valley Metro Rail, Inc. for the Central Mesa Light Rail Extension Project. The agreement allows Valley Metro to construct a Traction Power Sub Station (TPSS) in Morris Street right-of-way. The City will receive a license fee of \$94,700. Valley Metro Rail, Inc. will continue to be responsible for all costs associated with the operation and maintenance of the light rail transit system and all costs resulting from any accident or damage that may occur in the operation within the City property. This request will establish form-based zoning on the property. William Schneider, Turnstone Development Corporation of Arizona, applicant; Amelia/Tenth, LLC: Auret 1, LLC; PHD Equities, LLC, owners.

*6-b <u>15-0155</u> **Z15-002 (District 3)** The 500 through 800 blocks of East Auto Center Drive (north side). Located east of Mesa Drive on the south side of the Superstition Freeway (21.5± acres). Rezone from LI-PAD to LI-PAD and Site Plan Review to allow for the modification of the PAD for the development of an industrial park. Mike Withey, Withey Morris, applicant; Puppyfeathers Limited Partnership, owner.

Reese Anderson, Pew and Lake, applicant; RD Greenfield, LLC, owner.
