### \*4-a 15-0849 Three-Year Term Contract for Rigging and Over-Hire Stage Hand Services for the Mesa Arts Center (Citywide)

This contract will provide rigging services for the Mesa Arts Center. The vendor will be responsible for fly-rail operations, weight loading operations, high rigging and low rigging. These services are required to perform certain aspects of theater operations.

The evaluation committee recommends awarding the contract to the highest scored and most qualified proposal from Rhino Arizona, LLC, at \$500,000.00 annually, based on estimated requirements.

### \*4-b 15-0910 Term Contract for Electrical Products for various City Departments as requested by the Business Services Department (Citywide)

This contract will provide tools, test equipment, safety, and maintenance, repair and operations products in support of electrical, lighting, data/communications, networking and security for multiple City Departments, including Transportation, Communications, Facilities Maintenance, Information Technology, Fire and Medical, Parks, Recreation and Commercial Facilities, and the Materials and Supply Warehouse.

The Business Services Department and Purchasing recommend authorizing a contract using the County of Los Angeles cooperative contract with Graybar, at \$75,000.00 for the 6-month term, based on estimated requirements.

\*4-c 15-0909

Three-Year Term Contract for the Fabrication and Installation of Park Signs for the Parks, Recreation and Commercial Facilities Department (PRCF) (Citywide)

PRCF uses park identification signs, basin identification signs, rules signs, and other signs throughout the City's parks system for park identification and to inform and assist patrons in the proper use of park facilities.

The Parks, Recreation and Commercial Facilities Department and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Sierra Signs & Service, Inc. (a Mesa business), at \$467,000.00 annually, based on estimated requirements.

\*4-d 15-0908

Three-Year Term Contract for Audio-Visual Services for the Mesa Convention Center as requested by the Parks, Recreation and Commercial Facilities Department (Citywide)

This contract will provide audio-visual services and internet services to Mesa Convention Center clients. The agreement is non-exclusive, in that clients are permitted to bring their own equipment, but it is intended to assist all clients who require audio-visual services or rental equipment and provides consultation service and rental equipment through pre-agreed fees.

The evaluation committee recommends awarding the contract to the highest scored proposal from JLG Enterprises, Inc., dba Premier Audio Visual (a Mesa business), at \$160,000.00 annually, based on estimated requirements.

\*4-e 15-0911

Three-Year Term Contract for Landscape Maintenance Services for Parkway Medians and Right-of-Way - Section II for the Transportation Department (Districts 2, 3 and 4)

This contract will provide landscape maintenance services for the geographic area referred to by the City's Transportation Department as Section II. Work tasks include, but are not limited to: cleaning, irrigation, sprinkler system maintenance, trimming, mowing, weed control and fertilization. The awarded contractor will furnish all supervision, labor, and equipment to perform the required landscape maintenance services.

The evaluation committee recommends awarding the contract to the highest scored proposal from Artistic Land Management, Inc., at \$407,753.00 annually, based on estimated requirements.

#### \*4-f 15-0913

Term Contract for Heavy Duty Truck Parts and Repair Services for the Fleet Services Department (Citywide)

This contract will provide a full line of replacement parts, accessories and service for the City's heavy duty trucks, construction and industrial fleet and equipment parts.

The Fleet Services Department and Purchasing recommend authorizing a contract using the Maricopa County cooperative agreement with Empire Southwest, LLC (a Mesa business); Drake Equipment; Kenz & Leslie of Arizona; Lubrication Equipment and Supply Company; Norwood Equipment, Inc.; PTO Sales; and RDO Equipment; not to cumulatively exceed \$150,000.00, based on estimated requirements.

#### \*4-g <u>15-0912</u>

Three-Year Term Contract for Original Equipment Manufacturer (OEM) Heavy Duty Truck Repair Services for Peterbilt Trucks (Sole Source) (Citywide)

This contract will provide maintenance and repairs on the City's fleet of approximately 63 Peterbilt trucks. There are repairs that require specialized service, tools and training from an OEM authorized Peterbilt dealer and provides original manufacturer repair parts, a national warranty honored by all Peterbilt dealers and factory assistance reimbursement. Rush Truck is the only Peterbilt dealer in Arizona.

The Fleet Services Department and Purchasing recommend authorizing a three-year contract using the sole source vendor, Rush Truck Centers of Arizona, at \$60,000.00 annually, based on estimated requirements.

#### \*4-h 15-0915

Three-Year Term Contract for Waste Pumping and Hydro-Jetting Services for the Facilities Maintenance Department (Citywide)

This contract will provide waste pumping and hydro-jetting services on a scheduled or as-needed basis for City facilities. Services include removal, cleaning, and disposal of liquid and solid waste from traps, sand and oil interceptors, flow-through tanks, cesspools, septic tanks, and lift stations, as specified.

The evaluation committee recommends awarding the contract to the highest scored and lowest priced proposal from G Bar M Corporation, dba Overley's at \$35,000.00 annually, based on estimated requirements.

#### \*4-i 15-0907

Purchase of One Replacement All-Wheel Drive Backhoe for the Energy Resources Department (Citywide)

This purchase will provide one replacement rubber-tired all-wheel drive backhoe to support Energy Resources - Electric Utility operations. The vehicle being replaced has met established criteria and will be retired and sold at auction.

The Fleet Services and Energy Resources Departments, and Purchasing recommend authorizing the purchase from the contract with Empire Southwest, LLC (a Mesa business), at \$154,288.92. This purchase is funded by the Utility Replacement Extension and Renewal Fund.

#### \*4-j <u>15-0916</u>

Two-Year Term Contract for Water, Wastewater Laboratory Services for the Water Resources Department (Citywide)

Water Resources Department utilizes various outside laboratories to test water and wastewater samples for compliance with federal, state and local regulations. Mesa and six other agencies participated with Tempe as the lead in the RFP solicitation process.

The Water Resources Department and Purchasing recommend authorizing a two-year contract using the City of Tempe cooperative contract with Accutest Laboratories, Northern California, Inc.; Aquatic Consulting and Testing, Inc.; Eurofins Eaton Analytical, Inc.; Legend Technical Services of Arizona, Inc.; TestAmerica Laboratories, Inc.; and Trans West Analytical Services; cumulatively not to exceed \$150,000.00 annually, based on estimated requirements.

#### \*4-k 15-0918

Three-Year Term Contract for Hersey Brand Water Meter Maintenance for the Water Resources Department (Sole Source) (Citywide)

The City has over 200 Hersey brand water meters throughout Mesa that have been in service between 30 and 40 years. Water Resources has targeted these meters for replacement during the vault rehabilitation projects, requiring several years to complete. This contract will provide regular maintenance and parts to keep the existing meters operational until they are replaced.

The Water Resources Department and Purchasing recommend awarding the contract to the sole source vendor, Mueller Systems at \$30,000.00 annually, based on estimated requirements.

#### \*4-| 15-0893 Guerrero Rotary Park Playground Rehabilitation Project (District 4)

This rehabilitation will include new fabric shade structures installed over two areas of existing playground components, accessible ramps leading into the play areas and LED light fixtures added under the shade structures. Adding shade over the playground will increase opportunities for children to play while promoting opportunities for outdoor exercise and social interaction. The LED lights will facilitate use of the playground areas after sunset.

Staff recommends that Council award a contract to ELS Construction Inc., in the amount of \$224,631.90, and authorize a contingency for change orders in the amount of \$22,463.19 (change order allowance). This project is funded by a Community Development Block Grant (CDBG) and the Capital-General Fund.

Approving and authorizing the submittal of a Transportation Enhancement Grant application with the Arizona Department of Transportation for the construction of the Mesa Gateway Phase 2 Shared Use Pathway along the L202 Santan Freeway corridor from Elliot to Hawes Roads, and authorizing the City Manager to execute such documents as may be necessary to accept the grant, if awarded. The City's share will be 5.7% of the awarded funds. (**District 6**)

\*5-a 15-0887

Approving and authorizing the submittal of a grant application with the Arizona Department of Transportation for the purchase of a PM-10 certified street sweeper for FY 2016, and authorizing the City Manager to execute such documents as may be necessary to accept the grant, if awarded. The grant would allow the Transportation Department to purchase a new PM-10 certified sweeper specifically suited for sweeping pedestrian and bicycle paths and other areas with limited width. The City's share will be 5.7% of the awarded funds. (Citywide)
