#### 4 Take action on the following contracts:

\*4-a <u>15-0969</u> Three-Year Term Contract for Document Shredding Services for Citywide Departments as requested by the City Clerk (Citywide)

This contract provides on-site and off-site paper document shredding services and secure destruction of media including microfiche, microfilm, CD-ROMs, audio tapes, thumb drives, etc., on a routine or on-call basis.

The evaluation committee recommends awarding the contract to the highest scored proposals from The Centers for Habilitation (TCH), dba ASDD and Premier Document Shredding, Inc., at \$40,000 annually, based on estimated requirements.

# **\*4-b** <u>**15-0970**</u> Three-Year Term Contract for Helicopter Airframe Parts and Repair Services for the Police Department Aviation Unit (Citywide)

This contract will furnish parts, tooling, technical assistance and labor to overhaul and exchange airframe components, avionics and accessories for the Police Aviation Unit's three MD Helicopters.

The evaluation committee recommends awarding the contract to Seaside Helicopters, Inc., at \$500,000 annually, based on estimated requirements.

# \*4-c <u>15-0982</u> Purchase of One Replacement Front Loader with Box Scraper for the Water Resources Department (Citywide)

This purchase will provide a front loader with box scraper to support water treatment plant daily maintenance operations. The vehicle being replaced has met established criteria and will be retired and sold at auction.

The Fleet Services and Water Resources Departments, and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Empire Southwest, LLC (a Mesa business), at \$74,961.85. This purchase is funded by the Utility Replacement Extension and Renewal Fund.

# \*4-d <u>15-0983</u> One-Year Renewal of the Term Contract for Bio-Solids Removal and Reuse/Disposal Services for the Water Resources Department (Citywide)

This contract provides for all materials, equipment and labor to load, transport, and reuse/dispose of dewatered bio-solids from Mesa's Northwest and Greenfield Water Reclamation Plants. Bio-solids are removed from the plant site on a daily basis.

The Water Resources Department and Purchasing recommend authorizing a one-year renewal with Denali Water Solutions, LLC, at \$385,000.00 based on estimated requirements.

#### \*4-e <u>15-0988</u> Greenfield Water Reclamation Plant, Phase III Expansion (Citywide)

The City of Mesa, Town of Gilbert, and Town of Queen Creek ("the Owners") seek to provide an additional 14 million gallons per day annual average day flow of liquids and solids treatment capacity at the existing Greenfield Water Reclamation Plant, to provide a reliable, efficient, expanded plant to meet the current and future demands of the Owners.

Staff recommends that Council approve the selection of McCarthy Building Companies as the Construction Manager at Risk for this project and execute a pre-construction services contract in the amount of \$1,232,783.00. Mesa's portion is funded by the 2010 authorized Wastewater Bond.

#### \*4-f <u>15-0989</u> Val Vista Water Transmission Main - Phase 3 (Districts 1 and 3)

The City has initiated a three-phase project to build a new water transmission main parallel to the existing Val Vista Water Transmission Main that delivers water to three City-owned reservoirs. Mesa owns 90 million gallons per day at the Val Vista Water Treatment Plant and this transmission main will deliver water to the three City zone reservoirs.

Staff recommends that Council award a pre-construction services contract to Garney Construction as the Construction Manager at Risk for Phase 3 of the Val Vista Transmission Main in the amount of \$196,700.00. This project is funded by the authorized 2014 Water Bond.

# \*4-g <u>15-0986</u> Three-Year Term Contract for Real Property Escrow and Title Services for the Engineering Department (Citywide)

This contract will provide a qualified firm to perform a wide range of real property escrow and title services related to land acquisition for the Gilbert Road Light Rail Extension Project.

The evaluation committee recommends awarding the contract to the highest scored proposal from Security Title Agency Inc. (a Mesa business), at \$160,000.00 annually, based on estimated requirements. This purchase is reimbursed by Light Rail Project Funds.
