# \*5-a 20-0044 Three-Year Term Contract with Two Years of Renewal Options for Printed Envelopes for the Business Services Department (Citywide)

This contract will provide a vendor for a variety of printed envelope projects that are not economically possible for the Print Services Division to complete in-house.

The Business Services Department and Purchasing recommend awarding the contract to the lowest, responsive, and responsible bidder, Cenveo, at \$41,100 annually, with an annual increase allowance of up to 5%, or the adjusted Producer Price Index.

## \*5-b 20-0040

Dollar-Limit Increase to the Term Contract for Moving Services (Year 4) as requested by the Business Services Department (Citywide)

This contract was competitively bid but based on the annual contract threshold of \$25,000, management administratively approved this contract for Years 1 through 4. Year 4 has been a busier year for moving including the Fire and Medical Department; the Parks, Recreation and Community Facilities Department; the Community Services Department; and the Police Department, and additional funds are needed.

The Business Services Department and Purchasing recommend increasing the dollar-limit with Beltmann Relocation Group, by \$15,000, from \$25,000 to \$40,000 annually, for Year 4, based on estimated usage.

#### \*5-c 20-0031

Amendment to the Term Contract for Cellular Phone Equipment, Wireless Voice and Data Service Plan for Citywide Departments (as requested by the Information Technology Department) (Citywide)

The State of Arizona has extended their contract through 6/30/2020 to work on a new contract. As such, the City needs to extend its contract through 6/30/2020. Information Technology is also requesting an additional six-month extension option, which would be subject to NASPO/State of Arizona and Administrative review and approval, to allow for any transition needed, related to the new contract.

The Information Technology Department and Purchasing recommend extending the contract through June 30, 2020 using NASPO/State of Arizona cooperative contracts with Verizon, and AT&T Mobility; and adding vendors Sprint, T-Mobile, and DiscountCell, at \$2,145,000 annually, based on estimated usage.

#### \*5-d 20-0028

Three-Year Term Contract with Two Years of Renewal Options for On-Site Refuse Truck Washing Services for the Environmental Management and Sustainability Department (Citywide)

This contract will provide monthly washing of City-owned refuse vehicles by a crew with a mobile washing unit. The vendor furnishes all labor, materials, and equipment necessary to maintain the overall cleanliness of the exterior of City vehicles and equipment covered by this contract.

An evaluation committee recommends awarding the contract to the highest-scored proposal from Ace Mobile Wash, Inc., at \$52,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

\*5-e 20-0049

One-Year Renewal with a One-Year Renewal Option to the Term Contract for T-Shirts, Artwork and Graphics for the Parks, Recreation and Community Facilities Department (Citywide)

This contract provides pre-qualified vendors to supply t-shirts, design artwork, silkscreen, and graphics for the Parks and Recreation Division. Approximately 20,000 t-shirts are purchased throughout the year in various quantities and colors with a variety of artwork styles. The shirts are furnished to recreational event participants, volunteers, administrative staff, and other officials.

The Parks, Recreation and Community Facilities Department and Purchasing recommend authorizing the renewal with Vida Ventures, Inc., dba Rainbow Graffixx (a Mesa business); Koehler Parker, dba Logowear Express; Kimball Concepts Ltd (a Mesa business); Surf and Ski Enterprise (a Mesa business); and Lane Award Manufacturing, at \$45,000 annually, based on estimated usage.

\*5-f 20-0039

20-Month Term Contract with Two Years of Renewal Options for Shelving, Furniture and Equipment, and Materials as requested by the Library Services Department (Citywide)

This contract will provide furniture, displays and shelving, security equipment, security supplies, circulation technology solutions equipment and supplies, automated material handling and returns, and other supplies (replacement and addition) for each library branch location. In fiscal years 2020, 2021, and 2022, the Library Services Department will open and purchase equipment for the Mesa Express Library in a new location, remodel the Children's section of the Main Library, and construct a THINKspot at the Dobson Ranch Library. Additionally, the automated material handling machines at each branch are scheduled to be replaced over the next five years.

The Library Services Department and Purchasing recommend authorizing the purchase using the National Cooperative Purchasing Alliance contract with Demco, Inc., at \$350,000 annually, based on estimated requirements. This purchase is funded by the General Fund, General Capital Fund, and 2018 General Obligation Bonds.

\*5-g 19-1283

Three-Year Term Contract with Two Years of Renewal Options for Urban Lake Maintenance for the Parks, Recreation and Community Facilities Department (Citywide)

This contract will provide urban lake maintenance including water testing and analysis, mechanical equipment maintenance, and fish management for seven lakes within City boundaries. The urban fisheries and community lakes include Red Mountain Lake, Riverview Lake, Carriage Lane Lake, Dobson Ranch Lake, Greenfield Lake, Eastmark Lake, and Emerald Park Lake.

An evaluation committee recommends awarding the contract to the highest-scored proposal from Aquatic Consulting & Testing, Inc., at \$36,228 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

\*5-h 20-0027

Purchase of a Heavy-Duty Construction Truck with Dump Body (Addition) for the Parks, Recreation and Community Facilities Department as requested by the Fleet Services Department (Citywide)

This heavy-duty dump truck is required for cleaning parks, and will be used primarily for Signal Butte Park. It will also be used to clean up debris from the canal and water treatment plant nearby after rain storms.

The Parks, Recreation and Community Facilities and Fleet Services Departments, and Purchasing recommend approving the purchase from the existing contract with Freightliner of Arizona, at \$212,687.24, based on estimated requirements. This purchase is funded by the Environmental Compliance Fee.

\*5-i 20-0033

Three-Year Term Contract with Two Years of Renewal Options for Custodial Services - Zones 5, 6, and 7 for the Parks, Recreation and Community Facilities (PRCF) Department (Citywide)

Previously, a single Citywide contract for custodial services had been awarded; however, PRCF has determined that by splitting the City's buildings into three zones, it allows for better oversight and enforcement of contract terms and conditions for each zone. A single respondent scored the highest for each zone.

An evaluation committee recommends awarding the contract to the highest-scored proposal from Varsity Contractors, Inc., dba Varsity Facility Services, A KBS Company, at \$2,938,800 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

#### \*5-j 20-0050

Three-Year Term Contract with Two Years of Renewal Options for Light-Duty and Police Vehicle Maintenance and Repair Services for the Fleet Services Department (Citywide)

This contract will provide non-exclusive vendors for the maintenance and repair of the City's fleet of sedans, light duty trucks, sport utility vehicles, and vans. The City has approximately 1,178 light-duty vehicles that includes approximately 570 police vehicles, which are repaired and maintained jointly, by the City and outside vendors.

An evaluation committee recommends awarding the contract to the qualified proposals from Larry H Miller Ford Mesa (a Mesa business); B&T Vivian Investment Company LLC, dba Thompson's Auto Repair & Towing (a Mesa business); Viking Auto Repair, dba Dave's Auto Repair Clinic (a Mesa business); Friendly Auto Centers, LLC (a Mesa business); and Henry Brown Buick GMC, at \$250,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

#### \*5-k 20-0043

Purchase of a Mechanical PM-10 Street Sweeper with High Dump Capacity for the Transportation Department (Replacement) as requested by the Fleet Services Department (Citywide)

Transportation Field Operations will use this mechanical street sweeper to support their asphalt milling, slurry seal, and fog seal operations conducted by the department's Asphalt Repair and Pavement Preservation work groups. In addition, this sweeper will help Transportation meet the demands of their in-house street maintenance program and comply with Maricopa County dust regulations.

The Fleet Services and Transportation Departments, and Purchasing recommend awarding the contract to the lowest, responsive, and responsible bidder, Freightliner of Arizona, LLC, at \$269,954.92. This purchase is funded by the Local Streets Fund.

## \*5-I 20-0045

Four-Month Renewal with Four Years of Renewal Options to the Term Contract for Tires for the Materials and Supply Warehouse (for the Fleet Services and Mesa Fire and Medical Departments) (Citywide)

This contract provides Bridgestone tires, primarily large tires for heavy-duty vehicles such as solid waste trucks and fire apparatus. Different brands of tires are required to meet the needs of varying vehicles and applications and to match existing tires on vehicles and equipment.

The Business Services Department and Purchasing recommend authorizing the renewal using the NASPO/State of Arizona cooperative contracts with Redburn Tire Company (Mesa location); at \$150,000 annually, based on estimated usage.

## \*5-m 20-0029

Three-Year Term Contract with Two Years of Renewal Options for Audio Visual Diagnostics Parts and Services for the Fleet Services Department (Single Response) (Citywide)

This contract will provide audiovisual diagnostics parts and services for various City vehicles on an as-need basis. The solicitation included name brand specific items for cameras and radios, video units for backup cameras, and display rearview mirrors.

The Fleet Services Department and Purchasing recommend awarding the contract to the lowest, responsive, and responsible bidder, Freight Sales, Inc., dba Audio Express (a Mesa business), at \$75,000 annually, based on estimated requirements.

#### \*5-n 20-0047

One-Year Renewal with a One-Year Renewal Option to the Term Contract for LED Relamping Services for the Transportation Department (Citywide)

This contract provides services for the replacement of LED traffic signal indicators that are regularly replaced as they reach the end of their service life.

The Transportation Department and Purchasing recommend authorizing the renewal with Contractors West, Inc. (a Mesa business), at \$144,925 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

\*5-o 19-1325

One-Year Term Contract with Two Years of Renewal Options for Streetlight Parts and Electrical Supplies for the Transportation Department (Citywide)

This contract will provide streetlight parts and related electrical supplies including circuit breakers, power distribution blocks, lighting contactors, fuses, wire and cable, expansion fittings, starting aides (ignitors), photocells, high pressure sodium lamps, insulators, splicer assemblies, tap connectors, and submersible secondary connectors.

The Transportation Department and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Consolidated Electrical Distributors, dba Arizona Electric Supply (a Mesa business); at \$282,200 annually, with an annual increase allowance of up to 5%, or the adjusted Producer Price Index. This purchase is funded by the Local Streets Fund and Capital Improvement Program.

\*5-p <u>20-0038</u>

One-Year Renewal with a One-Year Renewal Option to the Term Contract for LED Modules for Traffic Control Signals for the Transportation Department (Citywide)

This contract provides LED modules for traffic signal lights to perform on-going traffic signal maintenance. These LED retrofit modules fit in all standard, incandescent traffic signal housings and can be used for the replacement of an incandescent signal indicator.

The Transportation Department and Purchasing recommend authorizing the renewal with Leotek Electronics USA, LLC, at \$112,700 annually, with an annual increase allowance of up to 5%, or the adjusted Producer Price Index.

\*5-q <u>20-0048</u>

One-Year Renewal with a One-Year Renewal Option to the Term Contract for Traffic Signal Maintenance Services for the Transportation Department (Citywide)

This contract provides for the maintenance, modification and installation of the City's Intelligent Transportation System Traffic Signals and related equipment on an as-needed, where-needed basis. Work includes foundation installation/removal, light and signal pole installation/removal, arm and head installation/removal, trenching, boring, conduit/wire/cable installation/removal, pull box/vault installation/removal, barricade set up, and saw cutting.

The Transportation Department and Purchasing recommend authorizing the renewal with Roadway Electric, LLC (Primary); and Contractors West, Inc. (a Mesa business) (Secondary); at \$980,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

#### \*5-r 20-0042

Dollar-Limit Increase to the Term Contract for Pipe Parts (Years 2 and 3) for the Materials and Supply Warehouse (for Citywide Use) (Citywide)

This contract provides pipe parts such as ells, elbows, nipples, caps, couplings, tees, and bushings that are stocked in the Warehouse. In an ongoing effort to put more items under contract, approximately 25 new line items have been added to the contract and the increase is needed for the increased contract usage.

The Business Services Department and Purchasing recommend increasing the dollar-limit with Dana Kepner Company, Inc.; Winsupply Inc., dba Thomas Pipe & Supply; and Four Peaks Fasteners Inc., dba FPF Industries, by \$20,000, from \$86,500 to \$106,500 annually, for Years 2 and 3, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

#### \*5-s 20-0041

Purchase of an X-Ray Kit for the Police Department (Sole Source) (Citywide)

This purchase of a Nexray FPX Nano X-Ray Kit is for the Police Department's existing bomb unit. The new equipment is lightweight and versatile, can scan both small and large items down range, and can be operated from a safe distance. The Nexray FPX Nano X-Ray Kit is the standard kit for the bomb squads in the Valley and squads across the country.

The Police Department and Purchasing recommend authorizing the purchase with Atlantic Diving Supply, at \$36,704.89, based on estimated requirements. This purchase is grant-funded by the Arizona Department of Homeland Security.

#### \*5-t 19-1233

Three-Year Term Contract with Two Years of Renewal Options for Leak Detection Equipment for Water Distribution and Transmission Mains for the Water Resources Department (Citywide)

The contract will provide an electronic water leak monitoring system to assist with minimizing water loss and the size of excavations and damage to streets when making water main repairs to underground water infrastructure. This technology allows for on-site monitoring for locating leaks between two points in the distribution system on any size or material of pipe and increases the sensitivity of the location of the leak to within 3 feet. The system will provide up-to-date software to enhance the City's leak detection program.

An evaluation committee recommends awarding the contract to the highest-scored proposal from Construction Product Marketing, LLC, at \$80,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.

\*5-u 20-0030

One-Year Renewal with a One-Year Renewal Option to the Term Contract for Backflow Testing and Repair Services for various City Departments (as requested by the Water Resources Department) (Citywide)

This contract provides backflow assembly testing and repair services to ensure the backflow assemblies are in good working condition and in compliance with municipal code for various departments including Transportation, Water Resources, and Parks, Recreation and Community Facilities.

The Water Resources Department and Purchasing recommend authorizing the renewal with Metro Fire Equipment, Inc., at \$165,000 annually, with an annual increase allowance of up to 5%, or the adjusted Consumer Price Index.
