Subject:	Purchase of Two (2) Replacement Sedans for the Fire and Medical Department (Funded by the Fire and Medical Services Budget) (Citywide)

Purpose and Recommendation

Council is requested to approve the purchase of two (2) vehicles as recommended.

Fire & Medical and Purchasing recommend authorizing the purchase from the contract with Courtesy Chevrolet at \$42,452.34.

Background / Discussion

This purchase will provide two, four-door sedans (2014 Chevrolet Impalas). The sedans will replace a 1999 ³/₄-ton Chevrolet pickup. The allotted funds for the replacement truck will cover the cost of the two sedans.

This purchase is part of the ongoing vehicle replacement program managed by Fire & Medical. The vehicle being replaced has met established criteria and will be retired and sold at auction.

Fire & Medical has requested the purchase of two sedans in lieu of the current pickup. Dispatch & Deployment currently has 35 employees with one vehicle to share for regional and local meetings. An additional vehicle would reduce staff's daily use of their personal vehicle for City business.

The sedans are additional purchases against a contract (through the City's bid process) originally awarded on May 6, 2013, which provided for additional purchases. The 2014 Impala LS sedans are available from Courtesy Chevrolet (dealer stock) and Courtesy provided a competitive quote for the vehicles.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The total amount of \$42,452.34 is available in the Fire & Medical budget through the Capital - General Fund.
