Subject:	Three (3)-Year Term Contract for Block Wall Cleaning, Painting and Minor Repair Services for the Transportation Department (Citywide)

#### **Purpose and Recommendation**

Council is requested to approve the Term Contract for Block Wall Cleaning, Painting and Minor Repair Services as recommended.

Transportation and Purchasing recommend awarding the contract to the lowest priced, responsive and responsible bidders, Hernandez Companies, Inc. (Primary) and Larkin Painting Contractors, Inc. (Secondary) at \$50,000 annually, cumulatively not to exceed.

## **Background / Discussion**

This contract will provide block wall cleaning, painting, and minor repair services on an asneeded basis at a variety of locations within City limits.

Transportation maintains numerous block walls throughout the City and contracts out the minor repair work, cleaning and painting services for the block wall maintenance.

## Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

#### **Fiscal Impact**

The total amount of \$50,000 is available in the Transportation operating budget through Local Streets Sales Tax Funding.
