A RESOLUTION OF THE COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AUTHORIZING THE CITY MANAGER OR HIS DESIGNATED REPRESENTATIVE, TO PREPARE, SIGN AND SUBMIT APPLICATIONS TO RECEIVE ENTITLEMENT FUNDS FOR FISCAL YEAR 2014/2015 UNDER THE HOUSING AND COMMUNITY DEVELOPMENT ACT OF 1974, AS AMENDED, TO FUND NON-PROFIT ORGANIZATION ACTIVITIES APPROVED BY THE CITY COUNCIL.

WHEREAS, the proposed activities to be undertaken were advertised and hearings held concerning the Community Development Block Grant ("CDBG"), in order to inform Mesa citizens and to receive comments regarding projects to be undertaken by the City in fiscal year 2014/2015 with the entitlement funds available for this program under the Housing and Community Development Act of 1974 ("Community Development Act"), as amended;

WHEREAS, the City Council was provided with recommendations of non-profit organization projects to be funded under the provisions of the Community Development Act and approved all projects and funding allocations;

WHEREAS, a proposed statement of the projected use of funds was completed in accordance with federal requirements and made available to the public; and

WHEREAS, the proposed activities to be undertaken by the non-profit organizations meet the objectives and priorities as identified in the City's Five-Year Consolidated Plan.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

Section 1: That the City Manager or his designated representative is hereby authorized to prepare, sign and submit applications to the U.S. Department of Housing and Urban Development for fiscal year 2014/2015 entitlement funds available to the City of Mesa under the Community Development Act for activities of non-profit organizations as approved by the City Council.

Section 2: The City Manager or his designated representative is authorized to amend and sign any amended applications without the further consent of the City Council, provided all said amendments or revisions are in compliance with the funding recommendations of the City Council, the City's Five-Year Consolidated Plan, the CDBG program, and the Community Development Act.
