Subject:	Purchase of Fleet Additions, including Two Light-Duty Pickup Trucks, for the Engineering Department (Funded by the Capital – General Fund) (Citywide)

Purpose and Recommendation

Council is requested to approve a contract to purchase additions to the fleet, two light-duty extended cab pickup trucks as recommended.

Fleet Services, Engineering and Purchasing recommend awarding the contract to the lowest priced, responsive and responsible bidder, Berge Ford (a Mesa business) at \$50,264.06.

Background / Discussion

This purchase will provide two fleet additions (2014 Ford 1/2-ton extended cab pickups) to support Engineering operations. The trucks will be used by their Construction Inspections group to inspect Capital Improvement projects. The fleet additions are needed for the increase in the number of Construction Inspectors in the department.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The total amount of \$50,264.06 is available through the Capital – General Fund.
