Subject: Purchase of Two Replacement Motorcycles for the Police Department
(Single Bid) (Funded by the Vehicle Replacement Fund) (Citywide)

Purpose and Recommendation

Council is requested to approve the purchase of two replacement motorcycles as recommended.

Fleet Services, Police and Purchasing recommend authorizing the purchase from the single bidder, Kelly's Kawasaki (a Mesa business) at \$62,393.28.

Background / Discussion

The Police Department's motorcycle fleet consists of twenty-nine units, twenty-five utilized for traffic enforcement and four older motorcycles for training new officers. Retaining the older units for training purposes prevents any damage to the new motorcycles. None of the four older units are assigned to officers for use on the street.

Two motorcycles were destroyed in collisions. The replacement motorcycles will maintain the fleet of twenty-nine. All costs (capital and up-fit) are included in the base contract price.

The replacement motorcycle for a Kawasaki ZG1400 was specified to be consistent with the existing motorcycle fleet.

This is an additional purchase against the contract awarded by Council on March 18, 2013.

Alternatives

Council may choose not to authorize the purchase.

Fiscal Impact

The total amount of \$62,393.28 is available in Fleet Services operating budget through the Vehicle Replacement Fund.
