#### 1. Review items on the agenda for the May 5, 2014 Regular Council Meeting.

**AN ORDINANCE OF THE CITY OF MESA, MARICOPA  
COUNTY, ARIZONA, MODIFYING THE WASTEWATER  
SCHEDULES OF TERMS, RATES, FEES AND CHARGES  
RELATING TO CITY OWNED UTILITIES**

BE IT ORDAINED by the City Council of the City of Mesa, Maricopa County, State of Arizona, as follows:

SECTION 1: That the Schedules and Titles of Terms, Rates, Fees and Charges for City-owned utilities are hereby established or amended and adopted to be applicable for the billing of utilities for the billing cycles ended on or after July 31, 2014, in accordance with the following:
