Subject:	Three-Year Term Contract for Refuse Container Bin Lids for the Solid Waste Management Department (Citywide)

Purpose and Recommendation

Council is requested to approve the Term Contract for Refuse Container Bin Lids as recommended.

Solid Waste Management Department and Purchasing recommend awarding the contract to the lowest priced, responsive and responsible bidder, Plastic Recovery Technology dba PRT at \$29,100.00 annually, based on estimated requirements.

Background / Discussion

This contract will provide 100% recyclable black lids that will be used for metal bin refuse containers for commercial customers throughout the City, for additional service requests and the replacement of damaged lids. The purchase is for approximately 1,500 36" x 58" lids and 150 36" x 41" lids annually. This contract will ensure Solid Waste Management readily has a supply of lids to meet the maintenance requirements of the City's bin inventory.

Mergon Corporation's response was deemed non-responsive because the vendor revised specifications and increased their bid pricing after bids were received.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The annual contract amount is funded by the Solid Waste Management department operating budget.
