**Subject:** Three-Year Term Contract for Landscape Maintenance Services for Parkway

Medians and Right-of-Way, Sections III (Districts 1, 2 and 5) and IV

(Districts 2 and 5) for the Transportation Department

# **Purpose and Recommendation**

Council is requested to approve the Term Contract for Landscape Maintenance Services for Parkway Medians and Right-of-Way, Sections III and IV as recommended.

Transportation and Purchasing recommend awarding the contract to the lowest priced, responsive and responsible bidder, Reyes & Sons Landscaping, LLC, Section III at \$230,742.68 annually and Section IV at \$137,639.25 annually, based on estimated requirements. The annual contract amount is \$368,381.93.

# **Background / Discussion**

This contract will provide landscape maintenance services for Parkway Medians and Right-of-Way for the geographic areas referred to by the City as Sections III and IV. Work tasks include but are not limited to cleaning, irrigation, sprinkler system maintenance, trimming, mowing, weed control, fertilization, etc. depending on whether the area is turf, desert, or a combination of both. The awarded Contractor will furnish all necessary labor, tools, equipment, and supplies to perform the required landscape maintenance services.

Per the bid solicitation, Contractors were required to bid Sections III and IV separately as the City intended to award the sections separately. Reyes & Sons Landscaping, LLC was the lowest priced respondent for each section. Additionally, all Sections shall be staffed, operated and maintained separately per contract requirements.

#### **Alternatives**

Council may choose not to authorize the purchase and new responses will be solicited.

### **Fiscal Impact**

The annual contract amount is funded by the Transportation department operating budget through Local Streets Sales Tax.
