A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, CANVASSING, DECLARING, AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD AUGUST 26, 2014

WHEREAS, on the 26th day of August 2014, the Primary Election of the qualified electors of the City of Mesa, Arizona, was held for the purposes set forth in Resolution No. 10428; and

WHEREAS, the City Council of the City of Mesa on this 11th day of September, 2014, did duly canvass the returns of the election as shown by the reports of the various election boards of the Primary Election; and

WHEREAS, the reports of the election boards as canvassed show that there were 61,701 ballots cast; and

WHEREAS, at the Primary Election, JOHN GILES received a number of votes constituting a majority of all the valid ballots cast for the office of Mayor and should be elected; CHRIS GLOVER received a number of votes constituting a majority of all of the valid ballots cast for the office of Councilmember – District 4 and should be elected; DAVID LUNA received a number of votes constituting a majority of all of the valid ballots cast for the office of Councilmember – District 5 and should be elected; and KEVIN THOMPSON received a number of votes constituting a majority of all of the valid ballots cast for the office of Councilmember – District 5 and should be elected; and KEVIN THOMPSON received a number of votes constituting a majority of all of the valid ballots cast for the office of Councilmember – District 6 and should be elected.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA, AS FOLLOWS:

Section 1. That JOHN GILES is declared to be elected to the office of Mayor.

<u>Section 2.</u> That CHRIS GLOVER is declared to be elected to the office of Councilmember – District 4

<u>Section 3</u>. That **DAVID LUNA** is declared to be elected to the office of Councilmember – District 5.

<u>Section 4</u>. That **KEVIN THOMPSON** is declared to be elected to the office of Councilmember – District 6.
