Subject: Purchase of Two Replacement Vehicles (Sedans) for the Police Department
(Funded by the Vehicle Replacement Fund) (Citywide)

Purpose and Recommendation

Council is requested to approve the purchase of two sedans for the Police Department as recommended.

Police and Purchasing recommend authorizing purchase from the contract with Berge Ford (a Mesa business) at \$49,110.08.

Background / Discussion

The Police Department needs to replace two vehicles in their fleet. One vehicle is part of the ongoing City of Mesa vehicle replacement program managed by Fleet Services; the vehicle has met established criteria and will be retired and sold at auction. The other vehicle was damaged in a collision and will also be replaced.

These vehicles are additional purchases against a contract (through the City's bid process) originally awarded on November 4, 2013, which provided for additional purchases.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

This purchase is funded by the Vehicle Replacement Fund.
