Subject: Three-Year Term Contract for Contractor Building Maintenance Services as

requested by the Facilities Maintenance Department (Citywide)

Purpose and Recommendation

Council is requested to approve the Term Contract for Contractor Building Maintenance Services as recommended. A committee representing Facilities Maintenance and Purchasing evaluated responses.

The evaluation committee recommends awarding the contract to the five highest scored proposals from Builders Guild Inc.; Diamond Ridge Development Corporation; Jokake Construction Services; Hernandez Companies, Inc.; and East Valley Disaster Services, Inc.; not to cumulatively exceed \$1,100,000.00 annually, based on estimated requirements.

Background / Discussion

On August 27, 2014, the City solicited Request for Qualifications (RFQ) to establish a prequalified vendors list for non-exclusive contractor building maintenance services on an asneeded basis. The awarded vendors will be placed onto the City's Pre-Qualified Building Maintenance Contractors List, and be eligible to competitively quote for City building maintenance and repair projects.

All work performed under this contract will be coordinated by the Facilities Maintenance Department. This contract will also replace Contract #2012147, for small maintenance and repair projects, when it expires September 30, 2015. The current contract is only for work up to \$25,000. The new contract removes this cap to allow Facilities to complete additional work that is needed. Facilities will obtain multiple quotes on jobs estimated over \$5,000.

The contractors will provide experienced journeyman to perform a variety of tasks including rough and finish carpentry, remodel work - such as walls, ceilings, doors, windows, drywall, stairs, tile, masonry, concrete, etc., and other repairs within City facilities.

Staff from the Facilities Maintenance evaluated the proposals based on the evaluation criteria. The five highest scored proposals, Guild Inc.; Diamond Ridge Development Corporation; Jokake Construction Services; Hernandez Companies, Inc.; and East Valley Disaster Services, Inc.; are being recommended for award. The evaluation committee unanimously agreed on the recommendation.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The annual contract amount is funded by Facilities Maintenance operating budget.
