Purpose and Recommendation

Council is requested to approve the Term Contract for Landscape Maintenance Services for Parkway Medians and Right-of-Way, Sections VI, as recommended.

Transportation and Purchasing recommend awarding the contract to the lowest priced, responsive and responsible bidder, Artistic Land Management, Inc., at \$226,183.14 annually, based on estimated requirements.

Background / Discussion

This contract will provide landscape maintenance services for Parkway Medians and Rightof-Way for the geographic areas referred to by the City as Sections VI. Work tasks include, but are not limited to, cleaning, irrigation, sprinkler system maintenance, trimming, mowing, weed control, fertilization, etc. depending on whether the area is turf, desert, or a combination of both. The awarded Contractor will furnish all necessary labor, tools, equipment, and supplies to perform the required landscape maintenance services.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The annual contract amount is funded by the Transportation department operating budget.
