Subject:	Three-Year Term Contract for Traffic Control Sign Materials and Sign Imaging for the Transportation Department (Citywide)

Purpose and Recommendation

Council is requested to approve the Term Contract for Traffic Control Sign Materials and Sign Imaging as recommended.

Transportation and Purchasing recommend awarding the contract to the lowest priced, responsive and responsible bidder, Safeway Sign Company at \$89,200.00 annually, based on estimated requirements.

Background / Discussion

Transportation Department's, Sign Shop staff uses traffic control sign materials and sign imaging to fabricate stop signs, speed limit signs, street name signs, and all other traffic control signs. These signs are installed throughout the City and materials include, reflective sign sheeting, street name sign blanks, metro sign blanks, and sign blanks.

Mendel Metals, Inc. dba US Standard Sign Co.'s response was determined to be nonresponsive because they did not submit pricing for all bid line items, as required by the solicitation.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The annual contract amount is funded by the Transportation department operating budget.
