Subject: One-Year Renewal of the Term Contract for Vector Control Services for the

Parks, Recreation and Commercial Facilities (PRCF) Department (Citywide)

Purpose and Recommendation

Council is requested to approve the Renewal of the Term Contract for Vector Control Services as recommended.

Parks, Recreation and Commercial Facilities and Purchasing recommend authorizing a one-year renewal with Checker Exterminating (a Mesa business) at \$76,500.00 annually, based on estimated requirements.

Background / Discussion

This contract provides for the treatment of mosquito vector control at all inlets and drains in 28 parks and 113 retention basins on a monthly or semi-monthly basis as designated. The contract will also provide as-needed services for the control of rodents, pests and weeds at all sites maintained by the PRCF Department. The PRCF will provide all chemicals used by the service vendor.

On February 24, 2014, Council approved the initial one-year contract with two, one-year renewal options. This is the first one-year renewal contract with one, one-year renewal option remaining.

Checker Exterminating, Inc. offered to renew the contract with an overall increase of 1.5% for minor increases in labor costs. This pricing is competitive compared to inflation (Consumer Price Index at 1.5%). Even with the 1.5% price increase, the pricing for this vendor is still less than the second lowest bid obtained last year. The City has been satisfied with the vendor's performance. This contract continues to be advantageous to the City and it is in the City's best interest to renew the contract.

Alternatives

Council may choose not to authorize the purchase and new bids will be obtained.

Fiscal Impact

The annual contract amount is funded by the Parks, Recreation and Commercial Facilities Department operating budget.
