**Subject:** Dollar Limit Increase to the Term Contract for Replacement Commercial

Grade Fitness Equipment and Supplies for the Parks, Recreation and

Commercial Facilities Department (District 5)

### **Purpose and Recommendation**

Council is requested to approve a dollar limit increase to the Term Contract for Commercial Grade Fitness Equipment and Supplies as recommended.

Parks, Recreation and Commercial Facilities and Purchasing recommend authorizing a dollar limit increase of \$120,000.00 with Fitness 4 Home Superstore, Inc. dba Commercial Fitness Superstore, increasing the contract amount from to \$106,000.00 to \$226,000.00 for this fiscal year, based on estimated requirements.

# **Background / Discussion**

This contract provides commercial grade fitness equipment and supplies including Cardio Fitness Equipment and Strength Fitness equipment. The Parks, Recreation and Commercial Facilities Department is requesting to replace Strength and Cardio Equipment at the Red Mountain Multigenerational Center. The Strength Fitness Equipment is fifteen years old; the manufacturer is no longer in business and replacement and repair parts are difficult to obtain. The Cardio equipment is seven years old and is four years past estimated life expectancy based on industry standards and hours of total use.

On September 24, 2012, Council approved the initial five-year contract with two, one-year renewal options. This increase request is for Year Three only. In the first two years of the contract, spending was significantly less than had been estimated. In Year One, only about \$89,000 of the \$186,000 estimated was spent and in Year Two, only about \$24,000 of the \$106,000 estimated was spent.

#### **Alternatives**

Council may choose not to authorize the increase and new bids will be obtained.

#### **Fiscal Impact**

This purchase is funded by the Parks, Recreation and Commercial Facilities Infrastructure Replacement Fund.
