Subject:	Change Order and Dollar Limit Increase to the Term Contract for Landscape Maintenance Services for Zones 1, 2 and 4 – Parks, Retention Basins and Sports Fields for the Parks, Recreation and Commercial Facilities (PRCF) Department (Districts 4 and 6)

Purpose and Recommendation

Council is requested to approve a change order and dollar limit increase to the Term Contract for Landscape Maintenance Services for Zones 1, 2 and 4 as recommended.

Parks, Recreation and Commercial Facilities and Purchasing recommend authorizing a change order and dollar limit increase of \$205,089.40 with Mariposa Landscape Arizona, Inc., increasing the contract amount from \$2,414,019.77 to \$2,619,109.17 annually, based on estimated requirements.

Background / Discussion

This contract provides landscape maintenance services for sports fields, parkways, medians, parks, retention basins, or grounds adjacent to City facilities—geographic areas referred by the City as Zones 1, 2, 4 and Eastmark Park.

The increase is necessary to add landscaping maintenance services for Mariposa Park and Phase II of Eastmark Park in Zone 1 and City View Park in Zone 4 and to increase the contract amount for Zones 1 and 2 to meet estimated requirements through the end of the contract term. The increased expenses in Zones 1 and 2 are due to storm cleanup work that had to be performed as extra work.

On January 13, 2014 Council approved the initial three-year term contract for Zone 4 and on March 17, 2014 approved the initial three-year term contract for Zones 1 and 2.

Alternatives

Council may choose not to authorize the increase and new bids will be obtained.

Fiscal Impact

The annual contract amount is funded through the Parks, Recreation and Commercial Facilities department operating budget.
