Subject: Three-Year Term Contract for Traffic Signal Meter Pedestals for the Materials and Supply Warehouse (for Transportation) **(Citywide)**

Purpose and Recommendation

Council is requested to approve the Term Contract for Traffic Signal Meter Pedestals as recommended.

Materials and Supply, Transportation and Purchasing recommend awarding the contract to the lowest priced, responsive and responsible bidder, Wesco Distribution at \$70,000.00 annually, based on estimated requirements.

Background / Discussion

This contract will provide Traffic Signal Meter Pedestals used by Transportation for maintenance of and modifications to existing traffic signalized intersections as well as construction of new traffic signalized intersections.

Arizona Electric Supply's response was determined to be non-responsive because the meter pedestals quoted do not conform to Mesa's specifications.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The annual contract amount is funded in the Materials and Supply operating budget through the Warehouse Internal Service Fund.
