Subject: Purchase of Three Replacement Light-Duty Animal Control Extended Cab

Transport Trucks for the Neighborhood Outreach/Animal Control Department

(Funded by the Vehicle Replacement Fund) (Citywide)

Purpose and Recommendation

Council is requested to approve the purchase of three replacement, light-duty animal control extended cab transport trucks as recommended.

Fleet Services, Neighborhood Outreach/Animal Control and Purchasing recommend authorizing purchase from the lowest, responsive and responsible bidder, Courtesy Chevrolet at \$163,043.13.

Background / Discussion

This purchase will provide three replacement vehicles (2015 Chevrolet 3/4-ton Animal Control Extended Cab Transport Trucks) to transport domestic animals to support Animal Control's daily operations.

The replacement vehicles are part of the ongoing City of Mesa vehicle replacement program managed by Fleet Services. The vehicles have met established criteria and will be retired and sold at auction.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

The purchase is funded by the Vehicle Replacement Fund.
