Subject: Three-Year Term Contract for Tire Maintenance and Repair Services for the

Fleet Services Department (Citywide)

Purpose and Recommendation

Council is requested to approve the Term Contract for Tire Maintenance and Repair Services as recommended. A committee representing Fleet Services and Purchasing evaluated responses.

The evaluation committee recommends awarding the contract to the highest scored proposal from Jack's Tire & Oil, LLC dba Jack's Tire & Oil at \$497,000.00 annually, based on estimated requirements.

Background / Discussion

This contract will provide tire maintenance and repair services on all wheeled equipment maintained by the Fleet Services Department. The City's overall fleet size is approximately 1,600 units. Work includes, but is not limited to: providing all labor, equipment, tools, service trucks(s) and services required for inspection, scheduled maintenance and repairs of all wheeled equipment (monitor and maintain proper tire pressure, check tire tread depth, rotate tires, repair, install new tires, inspect, and submit reports), and emergency road calls for repairs to wheeled equipment.

Staff from Fleet Services evaluated the proposals based on the evaluation criteria elements. The highest scored proposal, Jack's Tire & Oil, LLC dba Jack's Tire & Oil is being recommended for award. The evaluation committee unanimously agreed on the recommendation.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The annual contract amount is funded by the Fleet Services Department operating budget.
