- Subject: Purchase of One Replacement Rubber-Tired Wheel Loader for the Transportation Department (Funded by the Vehicle Replacement Fund) (Citywide)

#### **Purpose and Recommendation**

Council is requested to approve a contract to purchase one replacement rubber-tired wheel loader as recommended.

The Fleet Services and Transportation Departments, and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Empire Southwest, LLC (a Mesa business) at \$173,162.01.

#### **Background / Discussion**

This purchase will provide one replacement rubber-tired wheel loader with all-wheel drive, essential to support daily operations for the Transportation Department.

The vehicle purchase is part of the ongoing City of Mesa vehicle replacement program managed by Fleet Services. The vehicle being replaced has exceeded life cycle replacement criteria and will be retired and sold at auction.

The Life Cycle Cost Method was used for the bid evaluation. The evaluated purchase price equals *bid price less the buy-back price at 84 months (or 2,000 hours) plus guaranteed maximum repair cost.* The guaranteed maximum Preventative Maintenance (PM) and Repair Cost will be considered to be an annuity with the bid amount reflecting the maximum PM and repair costs for each time-line item listed.

Flaska JCB's response was determined to be non-responsive because of numerous deviations: overall dimensions of the backhoe (vendor left many responses blank); vendor required diagnostic software not available to the City; vendor will not allow the City to perform warranty work; and only offered a 24-month warranty.

#### Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

#### **Fiscal Impact**

This purchase is funded by the Vehicle Replacement Fund.
