Subject:	Three-Year Term Contract for Asphalt Materials for the Transportation, Energy and Water Resources Departments (Citywide)

### **Purpose and Recommendation**

Council is requested to approve the Term Contract for Asphalt Materials as recommended. A committee representing Transportation, and Purchasing evaluated responses.

The evaluation committee recommends awarding the contract to the highest scored proposals from Vulcan Materials Co., and Fisher Sand and Gravel Co. dba Southwest Asphalt; at \$789,000.00 annually, based on estimated requirements.

### **Background / Discussion**

This contract will provide hot mix asphalt for the repair of City streets for use by the Transportation Department and cold mix asphalt for temporary repairs for use by the Energy and Water Resources Departments.

Purchasing initially reviewed the two proposal responses to determine whether the minimum requirements were met. Both vendors qualified, and staff from Transportation evaluated the proposals based on the evaluation criteria as stated in the Request for Proposal solicitation. The highest scored proposals, Vulcan Materials Co. is being recommended as the Primary vendor, for Groups 1 and 2; and Southwest Asphalt is being recommended for Secondary award, for Group 1. The evaluation committee unanimously agreed on the recommendation.

### Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

### **Fiscal Impact**

The annual contract amount is funded by the Transportation, Energy Resources and Water Resources Departments operating budgets.
