Subject: Purchase of Wireless Network Infrastructure and Wi-Fi Access Points for the

Information Technology Department (Citywide)

Purpose and Recommendation

Council is requested to approve the Wireless Network Infrastructure and Wi-Fi Access Points as recommended.

Information Technology and Purchasing recommend awarding to the lowest responsive and responsible bidder, CDW Government LLC, at \$132,910.84.

Background / Discussion

Employees' increased use of mobile devices requires new and expanded Wi-Fi services in many City facilities in order to deliver City services or conduct City business. In addition, as planned in ITD's lifecycle roadmap, the City's wireless platform needs to be improved to support the changes in technology and growing demand. This purchase provides the wireless network solution and associated wireless access points for over 20 City facilities that lack coverage, need improved coverage or do not have Wi-Fi service. This solution provides needed security provisions to ensure protection of the City's data and network.

As the City expands Wi-Fi services for its employees in public facilities, the City will also need to provide new and expanded <u>public</u> Wi-Fi in facilities such as Falcon Field, Red Mountain Multigenerational Center, Community Rooms at the City's Fire Stations and Utilities building, City pools, Mesa Cemetery, Mesa Grande Museum, and expansion at the Municipal building and Mesa City Plaza. This solution will support additional public Wi-Fi opportunities as funding is identified. This aids the City's citizens as they attend events or come to City facilities to conduct business or obtain service. Free public-Wi-Fi is currently available at many City locations including; all Libraries, THINKspot, Mesa Arts Center, IDEA Museum, and Natural History Museum.

Council may choose not to authorize the purchase and new responses will be solicited.
