Subject:	Purchase of Additional Maintenance Equipment for Riverview Park for the Parks, Recreation and Commercial Facilities Department (Citywide)

Purpose and Recommendation

Council is requested to approve the purchase of Additional Maintenance Equipment for Riverview Park as recommended.

The Parks, Recreation and Commercial Facilities Department and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Simpson Norton Corporation at \$102,012.71.

Background / Discussion

This purchase will provide one large area reel mower and one light duty utility cart, used to maintain Riverview Park's Multi-Purpose Facility (parking/soccer fields).

Simpson Norton of Arizona, is being recommended for award for both items. Simpson offered the lowest price for the utility cart, but is the higher of the two bids for the large area mower. Jacobsen, the lowest bid for the mower did not meet the required minimum bid specifications on several areas: overall cutting width does not meet the minimum of 121", cut height does not meet the .05 to 2.0" requirement, and fuel tank does not meet the 22-gallon minimum.

Alternatives

Council may choose not to award the purchase and new bids will be obtained.

Fiscal Impact

This purchase is funded by the Parks, Recreation and Commercial Facilities Department budget through the Enterprise Fund - Cubs Spring Training Facility.
