Subject:	Three-Year Term Contract for Traffic Control Sign Hardware and Materials for the Transportation Department (Citywide)

#### **Purpose and Recommendation**

Council is requested to approve the Term Contract for Traffic Control Sign Hardware and Materials as recommended.

The Transportation Department and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidders: Traffic and Parking Control Co, Inc. (TAPCO); It-Straps-On, Inc. dba Core Products USA, Inc.; and Centerline Supply West, Inc.; cumulatively not to exceed \$40,000.00 annually, based on estimated requirements.

## **Background / Discussion**

This contract will provide traffic control sign hardware and materials to upgrade signs throughout the City. The items contracted through this agreement include mounting brackets and hardware, overhead sign brackets, delineators, tube post covers and bases.

## Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

The annual contract amount is funded by the Transportation Department operating budget.
