Subject: Purchase of One Replacement Heavy Duty Truck with 50 Foot Telescopic Aerial Device and Utility Body for the Transportation Department **(Funded by the Vehicle Replacement Fund) (Citywide)**

Purpose and Recommendation

Council is requested to approve a contract to purchase a Heavy Duty Truck with 50 Foot Telescopic Aerial Device and Utility Body as recommended.

The Fleet Services, and Transportation Departments, and Purchasing recommend awarding the contract to lowest, responsive and responsible bidder, Altec Industries, Inc. (a Mesa business) at \$211,665.63.

Background / Discussion

This purchase will provide a heavy duty, construction grade, 4x2 truck equipped with a 50 ft. articulated/telescopic aerial device and utility body. The truck will be used to support the maintenance and installation of: electrical (energized appliances), luminaires and streetlights, and used to tow pole trailers for the Transportation Department.

The vehicle purchase is part of the ongoing City of Mesa vehicle replacement program managed by Fleet Services. The vehicle being replaced has met replacement criteria and will be retired and sold at auction.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

This purchase is funded by the Vehicle Replacement Fund.
