**Subject:** Additional Contractor Award to the Three-Year Term Contract for Debris Collection and Disposal Services for the Transportation Department  
(Citywide)

## Purpose and Recommendation

Council is requested to approve an Additional Contractor Award to Term Contract for Debris Collection and Disposal Services as recommended.

Transportation and Purchasing recommend awarding the contract to the second, lowest, responsive and responsible bidder, Garbage Guy Inc., as the Secondary Vendor.

## Background / Discussion

On April 20, 2015, Council awarded the contract to King Concrete Inc. at \$185,000.00 annually as recommended. The Secondary contractor award was inadvertently left out of the Council recommendation. Transportation and Purchasing are now requesting to add the secondary contractor award.

The bid allowed for multiple awards, and the City intended to award to a Primary and Secondary contractor. The Primary contractor will provide debris collection and collection services until such time the City determines that it is in the City's best interest to demand performance from the Secondary contractor. The decision will be based upon the Primary contractor's ability to provide acceptable debris collection and disposal services within the City's time requirements.

## Alternatives

Council may choose not to authorize the Secondary contractor award.

## Fiscal Impact

The annual contract amount is funded by the Transportation Department operating budget through Local Streets Sales Taxes.
