Subject: One-Year Renewal of the Term Contract for Concession Services for the

Mesa Arts Center (District 4)

#### **Purpose and Recommendation**

Council is requested to approve the Renewal of the Term Contract for Concession Services as recommended.

The Mesa Arts Center and Purchasing recommend authorizing a one-year renewal with Atlasta Catering Service, Inc. For the management of concessions at Mesa Arts Center, the vendor pays the City a commission percentage of the gross receipts for food, beverage and liquor sales for concession services; and for catering services.

### **Background / Discussion**

This contract provides a qualified and reputable business for the provision of food and beverages (alcoholic and non-alcoholic) for concessions. The company has catering and concessions operations at the Mesa Arts Center, has dedicated onsite staff to manage the food and beverage operations, and maintains strong customer service, image and perception.

Through this contract, the City receives a commission on the percentage of the gross receipts for food, beverage and liquor sales for concession services; and for catering services. The vendor is willing to maintain the same commission structure for the renewal. The City has been satisfied with vendor performance. This contract continues to be advantageous to the City and it is in the City's best interest to renew the contract.

On July 10, 2012, management approved the initial three-year term contract with renewal options. This is the first, one-year renewal with a one-year renewal remaining. Future renewal will be subject to Council consideration.

#### **Alternatives**

Council may choose not to authorize the purchase and new bids will be obtained.

#### **Fiscal Impact**

The City provides the vendor the exclusive right to provide concession services and nonexclusive right for catering services. The vendor pays commission of all gross receipts for food, beverage and liquor sales (30% of gross receipts for food, beverage and liquor sales for concession services; and 20% for food and beverage (non-alcoholic) and 30% for liquor sales for catering services).

## **Description**

City to provide vendor the exclusive right to provide concession services, and non-exclusive right for catering services. Vendor to pay the City the following commissions of all gross receipts for food, beverage and liquor sales.

# Concession Service

Food and Beverage (non-Alcoholic) 30% to the City Liquor sales 30% to the City

#### **Catering Service**

Food and Beverage (non-Alcoholic) 20% to the City Liquor sales 30% to the City
