Subject: Three-Year Term Contract for the Fabrication and Installation of Park Signs

for the Parks, Recreation and Commercial Facilities Department (Citywide)

Purpose and Recommendation

Council is requested to approve the Term Contract for the Fabrication and Installation of Park Signs as recommended.

The Parks, Recreation and Commercial Facilities Department and Purchasing recommends awarding the contract to the lowest, responsive and responsible bidder, Sierra Signs & Service, Inc. (a Mesa business) at \$467,000.00 annually, based on estimated requirements.

Background / Discussion

The Parks, Recreation and Commercial Facilities (PRCF) Department uses park identification signs, basin identification signs, rules signs, and other signs throughout the City's Parks system for park identification and to inform and assist patrons in the proper use of park properties.

This contract will provide a Contractor to fabricate and install new standard identification and rules signs at City parks and facilities in a phased approach. The new signs will update the look and wording to create a more modern and consistent message. Changes in the City Code pertaining to Park regulations have been incorporated and standardized across all PRCF facilities. The old signs will be removed at the time of new sign installations.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The annual contract amount is available in the Project Management Program Department budget through the Capital – General Fund.
