Subject: One-Year Renewal of the Term Contract Bio-Solids Removal and Reuse/
Disposal Services for the Water Resources Department **(Citywide)**

Purpose and Recommendation

Council is requested to approve the Renewal of the Term Contract for Bio-Solids Removal and Reuse/Disposal Services as recommended.

The Water Resources Department and Purchasing recommend authorizing a one-year renewal with Denalli Water Solutions, LLC at \$385,000.00, based on estimated requirements.

Background / Discussion

This contract provides for all materials, equipment and labor to load, transport, and reuse/dispose of dewatered bio-solids from Mesa's Northwest and Greenfield Water Reclamation Plants. Loading and hauling are included therefore all bio-solids dewatered during the previous 24-hours are removed from the plant site daily.

On November 5, 2012, Council awarded the initial three-year contract to Terra Renewal West with renewal options. Effective November 3, 2014, this vendor formally changed their legal name/entity of Terra Renewal West to Denalli Water Solutions, LLC. This is the first, one-year renewal contract with a one-year renewal option remaining.

Denalli Water Solutions offered to renew the contract with no price increase and the pricing is competitive compared to inflation (Consumer Price Index at 4.068 %). The City has been satisfied with the vendor's performance. It would be costly to transition vendors as it takes much time for a new vendor to learn the City's needs and requirements. This contract continues to be advantageous to the City and it is in the City's best interest to renew the contract.

The Greenfield Water Reclamation Plant Expansion should be near completion in 2018. The amount of bio-solids to be removed will significantly increase. The City will resolicit this contract at that time.

Alternatives

Council may choose not to authorize the purchase and new bids will be obtained.

Fiscal Impact

The annual contract amount is funded by the Water Resources Department operating budget through the Enterprise Funds, Wastewater Sub Fund and Greenfield WRP Joint Venture.
