Subject: One-Year Renewal of the Term Contract for Fiberglass Waterslide Repair for

the Parks, Recreation and Commercial Facilities Department (Citywide)

Purpose and Recommendation

Council is requested to approve the Renewal of the Term Contract for Fiberglass Waterslide Repair as recommended.

The Parks, Recreation and Commercial Facilities Department, and Purchasing recommend authorizing a one-year renewal with 8 Blocks Maintenance Co., LLC at \$54,000.00, based on estimated requirements.

Background / Discussion

This contract provides for the repair, waxing and buffing of the City's fiberglass waterslides at various locations. Each year, preventative maintenance and repairs on every waterslide at each Aquatics facility is necessary. It is the only way to ascertain the fiberglass is safe and will not cause injury to a potential rider for the upcoming year. Any slivers, grooves, and/or fiberglass shards that may cut riders are sanded off and polished to help maintain the overall safety and appearance of the slide. It is during this service that potential leaks are found and can be repaired before major damage occurs.

On December 21, 2011, management approved the initial three-year contract with renewal Options. On December 1, 2014, Council approved the first, one-year renewal contract. This is the second and final, one-year renewal option.

8 Blocks Maintenance Co., LLC offered to renew the contract without a price increase. This vendor has maintained pricing over the past four years. The Consumer Price Index has increased by more than 3.5% over the past four years. The City has been satisfied with the vendor's performance. This contract continues to be advantageous to the City and it is in the City's best interest to renew the contract.

Alternatives

Council may choose not to authorize the purchase and new bids will be obtained.

Fiscal Impact

The annual contract amount is funded by the Parks, Recreation and Commercial Facilities Department operating budget.
