Subject: Purchase of One Replacement Material Handling Lift Truck for the Water

Resources Department (Funded by the Utility Replacement Extension &

Renewal Fund) (Citywide)

Purpose and Recommendation

Council is requested to approve a contract for the purchase of one replacement material handling lift truck as recommended.

The Fleet Services, and Water Resources Departments, and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Forklift Exchange, Inc. dba Flaska JCB at \$67,140.59.

Background / Discussion

This purchase will provide one replacement pneumatic tire, material handling, telescopic, lift truck to support Wastewater Utility's daily maintenance operations.

This vehicle purchase is part of the ongoing City of Mesa vehicle replacement program managed by Fleet Services. The current vehicle has exceeded life cycle replacement due to age, has high maintenance costs, and will be retired and sold at auction.

Council may choose not to authorize the purchase and new responses will be solicited.
