Subject: Three-Year Term Contract for Traffic Signal Loop Detection Installation Services for the Transportation Department **(Citywide)**

Purpose and Recommendation

Council is requested to approve the Term Contract for Traffic Signal Loop Detection Installation Services as recommended.

The Transportation Department and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Kimbrell Electric, Inc. at \$131,000.00 annually, based on estimated requirements.

Background / Discussion

This contract will provide for the installation of new and the maintenance/replacement of existing traffic signal loops for the Transportation's Intelligent Transportation System (ITS) Operations group. Functional loop detectors are essential for detecting vehicles so traffic signals move vehicles efficiently. Work includes barricade set-up, saw-cutting and traffic loop installation per bid specifications.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The annual contract amount is available in the Transportation Department operating budget through the Local Streets Sales Tax funding.
