Purpose and Recommendation

Council is requested to approve the Purchase of a Pneumatic Tire Lift Truck with Rotator Attachment for the Environmental Management and Sustainability Department as recommended.

The Fleet Services and Environmental Management and Sustainability Departments, and Purchasing recommend authorizing the purchase from the lowest, responsive and responsible bidder, Arnold Machinery Company at \$71,501.83.

Background / Discussion

This purchase will provide a Pneumatic Tire Lift Truck with Rotator Attachment to move solid waste containers during maintenance welding and repairs.

The replacement vehicle is part of the ongoing City of Mesa vehicle replacement program managed by Fleet Services. The vehicle being replaced has met established criteria and will be retired and sold at auction.
