Subject: Renewal of the Term Contract for Accessible Pedestrian Signal Push Buttons for the Materials and Supply Warehouse (for the Transportation Department) (Single Bid) (Citywide)

Purpose and Recommendation

Council is requested to approve the Renewal of the Term Contract for Accessible Pedestrian Signal Push Buttons as recommended.

The Business Services, and Transportation Departments, and Purchasing recommend authorizing a one-year renewal with JTB Supply Co. at \$76,000.00, based on estimated requirements.

Background / Discussion

This contract provides Accessible Pedestrian Signal (APS) Push Buttons for the visually impaired and those needing assistance at traffic signalized intersections. The buttons are stocked at the Materials and Supply Warehouse to be used by the Transportation Department for installation throughout the City.

The City currently uses the Campbell Station APS push buttons because they are the only manufacturer that makes a push button unit that fits in the City's standard pedestrian push button housing (ADOT standard), saving the City time and money. No other manufacturers offer a button solution for the City's standard housing.

On April 15, 2013, Council approved the initial three-year contract with renewal options. This is the first, one-year renewal contract with a one-year renewal option remaining.

Fifty-five vendors (including one Mesa vendor) were invited to submit a response, in addition to the standard advertising in the Arizona Republic, Bid Net, Record Reporter and the City of Mesa Purchasing website. Twenty-two vendors downloaded the solicitation. One bid response and one "No Bid" response were received.

The vendor offered to renew the contract without a price increase. The CPI has increased 2.5% since the original contract award. The City has been satisfied with the vendor's performance. This contract continues to be advantageous to the City and it is in the City's best interest to renew the contract.

Alternatives

Council may choose not to authorize the purchase and new bids will be obtained.

Fiscal Impact

The annual contract amount is available through the Warehouse Internal Service Fund.
