Subject: Purchase of One Replacement Light-Duty Cab and Chassis Vehicle with a Utility Bed for the Water Resources Department (**Funded by the Utility Replacement Extension & Renewal Fund**) (Citywide)

Purpose and Recommendation

Council is requested to approve the purchase of one replacement light-duty, 4X2 cab and chassis vehicle with an 11 ft. utility bed as recommended.

The Fleet Services and Water Resources Department, and Purchasing recommend authorizing the purchase from the contract with PFVT Motors Inc. at \$40,607.20.

Background / Discussion

This purchase will provide one, 2016 Ford F-350, 1-ton, 4X2 regular cab and chassis, 84" cab to axle equipped each with an 11 ft. utility bed. The vehicle will support Water Utility's daily operations and maintenance activities.

The proposed vehicle is part of the ongoing City of Mesa vehicle replacement program managed by Fleet Services. The vehicle being replaced has met established criteria and will be retired and sold at auction.

The proposed vehicle is an additional purchase from a contract Council awarded on October 23, 2014 that allows additional purchases.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

This purchase is funded by the Utility Replacement Extension & Renewal Fund.
