SUBJECT: Appointment to Boards and Committees

The following are my recommendations for appointments to City of Mesa Advisory Boards and Committees.

Early Childhood Education Task Force – Thirteen-member board with one new appointment.

<u>Dr. Dawn Foley</u>. Dr. Foley is the Curriculum and Instruction Director for Mesa Public Schools.

Library Advisory Board – Nine-member board with one new appointment.

Alexis Ross, District 4. Ms. Ross is a student at Mesa High School. She has volunteered with the library for nearly two years including assisting with the Summer Reading Program, and Sensory Story time. Ms. Ross is a member of the Cardon Childrens Advisory Board. Ms. Ross will be filling the student representative position on the Library Board, vacated by Andrea Garza. Her partial term will end June 30, 2016.

Parks & Recreation Advisory Board – Eleven-member board with one new appointment.

Sarah Johnston, District 3. Dr. Johnston is an Assistant Professor at A.T. Still University and Faculty Associate at ASU. She hold a PhD from ASU and a Bachelor of Science from the University of Oregon. Dr. Johnston volunteers her time providing nutrition outreach to middle school students. Dr. Johnston will be filling a vacancy created by the resignation of Miguel Sosa. Her partial term will end June 30, 2018.
