Subject: Three-Year Term Contract for Video Surveillance Equipment and Parts for the Police Department (**Funded by Lifecycle Program and 2015 Edward Byrne Justice Assistance Grant (JAG) Program**) (Citywide)

Purpose and Recommendation

Council is requested to approve the Term Contract for Video Surveillance Equipment and Parts as recommended.

The Police Department and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidders: Affirmative Technology Group; Mark Joseph Perlmutter dba Perlmutter Purchasing Power; and Tyco Integrated Security LLC; cumulatively not to exceed \$220,000.00 for Year 1, and \$150,000.00 annually for subsequent Years 2 and 3, based on estimated requirements.

Background / Discussion

This contract will provide video surveillance equipment and parts to upgrade the video surveillance systems at various locations throughout the City. Police Department personnel will coordinate these purchases.

The evaluation team determined that awards would be made by category. The vendor selected for each category provided prices for all line items within the category and had the lowest combined total for all line items in the category.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The first-year contract amount is available in the Lifecycle Program LF0127-CCTV System Upgrade-Video Surveillance (\$100,000.00), and from the 2015 Edward Byrne Justice Assistance Grant (JAG) Program (\$120,000.00).

The subsequent second and third-year contract amount is available in the Lifecycle Program (\$100,000.00) and the Police Department operating budget (\$50,000.00).
