AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA ADOPTING TITLES AND SCHEDULES OF TERMS, RATES, FEES AND CHARGES FOR CITY-OWNED WASTEWATER UTILITIES

BE IT ORDAINED by the City Council of the City of Mesa, Maricopa County, State of Arizona, as follows:

Section 1: That the following Titles and Schedules of Terms, Rates, Fees and Charges for City-Owned Wastewater Utilities, as made public record by Resolution adopted on May 2, 2016, three copies of which are on file and available for public use and inspection with the Office of the City Clerk, are hereby established or amended and adopted to be applicable for the billing of utilities commencing with the August 2016 billing cycles:
