Subject:	Purchase of One Replacement CNG Material Handling Lift Truck for the Fleet Services Department (Funded by the Vehicle Replacement Fund) (Citywide)

Purpose and Recommendation

Council is requested to approve a contract for the purchase of one replacement CNG material handling lift truck as recommended.

The Fleet Services, and Water Resources Departments, and Purchasing recommend awarding the contract to the lowest, responsive and responsible bidder, Arnold Machinery at \$36,814.10.

Background / Discussion

This purchase will provide one replacement Compressed Natural Gas (CNG) pneumatic tire, material handling, lift truck (forklift) to support Fleet Services Department's daily operations and various needs.

This vehicle purchase is part of the ongoing City of Mesa vehicle replacement program managed by Fleet Services. The current vehicle has exceeded life cycle replacement and will be retired and sold at auction.

Council may choose not to authorize the purchase and new responses will be solicited.
