### **2. Approval of minutes from a previous meeting as written.**

It was moved by Boardmember Luna, seconded by Boardmember Glover, that the minutes from the November 19, 2015 Eastmark Community Facilities District No. 1 Board meeting be approved.

Approving and authorizing the issuance of Eastmark Community Facilities District No. 1 (City of Mesa, Arizona) Assessment District No. 5, Special Assessment Revenue Bonds, Series 2016, approving the form and authorizing and execution and delivery of various documents related thereto; awarding the bonds to the purchaser thereof; appointing a registrar, transfer agent and paying agent for the bonds; and taking other actions securing the payment of and relating to the bonds – Resolution No. CFD EM1 RES 34.

It was moved by Boardmember Glover, seconded by Boardmember Luna, that Resolution No. CFD EM1 RES 34 be adopted.

Chairman Giles declared the motion carried unanimously by those present and Resolution No. CFD EM1 RES 34 adopted.
