# **Purpose and Recommendation**

Council is requested to approve the Renewal of the Term Contract for Ammunition as recommended.

The Police Department and Purchasing recommend authorizing a five-month renewal with San Diego Police Equipment Co, Inc., Miwall Corporation and Professional Police Supply dba Adamson Police Products, cumulatively not to exceed \$350,000.00, based on estimated requirements.

# **Background / Discussion**

On April 15, 2013, Council approved the initial three-year term contract. Mesa as the lead/issuing agency, together with City of Tempe Police Department, Navajo County Sheriff's Office, and Cochise County Sheriff's Office solicited bids to enter into a contract with vendors for the purchase of ammunition. Specifications and requirements of each agency were included in the bid solicitation. Mesa's ammunition was bid included 20 line items representing frangible (training) and duty ammunition items.

A new contract is being resolicited. Renewal is being requested because the solicitation is taking longer than expected because it will a national cooperative contract led by the City.

#### **Alternatives**

Council may choose not to authorize the renewal, however due to the long lead times for ammunition, PD will need to find an alternative source.
