Purpose and Recommendation

The purpose of this report is to provide information on a proposed Development Agreement for City Share Reimbursement between Pulte Home Corporation, a Michigan corporation, hereinafter referred to as "Developer", and the City of Mesa, hereinafter referred to as "Mesa", for the reimbursement of \$464,648.00 for regional street, water line, drainage and street lighting improvements that are being required by Mesa in conjunction with the proposed residential development known as Bella Via – Parcel 12 and 15, located at 5261 South Signal Butte Road, hereinafter referred to as "Development".

Staff recommends Council approve the Development Agreement for Reimbursement of City Share and the Resolution authorizing the City Manager or his designee to sign the Development Agreement.

Background

The Developer is proposing to construct a development known as Bella Via- Parcel 12 and 15, located at 5261 South Signal Butte Road, as shown on exhibit "A" within the attached Development Agreement. The Development is subject to the regulations contained in Title Nine, Chapters Six and Eight of the Mesa City Code, which requires the Developer to design and install the offsite improvements adjacent to the proposed development as required by Mesa standards. Offsite regional improvements are being required to ensure that Mesa's minimum standards for transportation and infrastructure are maintained.

Discussion

Mesa is requiring the Developer to install regional street, water line, drainage and street lighting improvements along South Signal Butte Road, Mesa proposes to financially participate in the regional improvement costs and will reimburse the Developer for Mesa's share of the costs as identified within exhibit "B" of the attached Development Agreement for City Share Reimbursement.

The Developer has agreed to install the regional street, water line, drainage and street lighting improvements along South Signal Butte Road and to follow the terms and conditions of the Development Agreement by providing Mesa with copies of all contracts, invoices, lien releases and proof of payments that clearly and accurately document the unit costs that were paid by the Developer for the regional offsite improvements.

In order for Mesa to reimburse the Developer for Mesa's share of project costs, Mesa must enter into the attached Development Agreement.

Alternatives

One alternative would be for Mesa to not enter into the Development Agreement. This would mean that the Developer would most likely not install any of the regional improvements that are necessary to provide for Mesa's transportation and infrastructure required to meet the overall regional need of the development of the property within this area.

This alternative is not recommended at this time due to the public need to complete the regional improvements.

Fiscal Impact

In accordance with Mesa's City Share policy and guidelines, Mesa's estimated City Share on this Development is \$464,648.00 (see exhibit "B" within the Development Agreement for details).

Mesa's Share of funding for the improvements is budgeted in the Transportation Department's FY 2016/2017 budget (Fund 1307, Major Program CN0003, Phase 104) and Water Resources Department's FY 2016/2017(Fund 3107, Major Programs CP0652, Phase 104).

Coordinated With

The Development Services, Transportation and Water Resources Departments concur with this recommendation.
