Subject:	Three-Year Term Contract for Compressed Natural Gas (CNG) Station Maintenance for the Environmental Management & Sustainability Department (Citywide)

Purpose and Recommendation

Council is requested to approve the Term Contract for CNG Station Maintenance as recommended.

The Environmental Management & Sustainability, and Energy Resources Departments, and Purchasing recommend awarding the contract to the highest scored proposal, Trillium Transportation Fuels, LLC at \$125,000.00 annually, based on estimated requirements.

Background / Discussion

The CNG station at 730 N. Mesa Drive is being built pursuant to a design and installation agreement with Caliente Construction. This contract will provide for the maintenance, parts and repair of this CNG station including compressors, dispensers, storage, and all other associated parts/equipment. The contractor will also provide semi-annual training for City employees relating to maintenance requirements of the CNG station.

Staff from the Environmental Management & Sustainability, and Energy Resources Departments, and Purchasing evaluated the proposals based on the evaluation criteria as stated in the solicitation. The highest scored proposal, Trillium Transportation Fuels, LLC is being recommended for award. The evaluation committee unanimously agreed on the recommendation.

Alternatives

Council may choose not to authorize the purchase and new responses will be obtained. If postponed, the CNG station may be commissioned without a maintenance provider.

Fiscal Impact

The annual contract amount includes is funded by the Energy Resources Department operating budget through the Enterprise Fund – Gas Utility Sub Fund.
