Subject: Three-Year Term Contract for an Audible Panic System as requested by the Police Department (**\$23,986 grant funded by Arizona Criminal Justice Commission Grant Funds and \$14,014 funded by the Police Department operating budget**) (Citywide)

Purpose and Recommendation

Council is requested to approve the Term Contract of an Audible Panic System as recommended.

The Police Department and Purchasing recommend awarding the contract to the lowest, responsible and responsive bidder, Tyco Integrated Security, LLC at \$100,000.00 annually, based on estimated requirements.

Background / Discussion

There are instances in the Police Department's Forensic Services Division when members may be working in a laboratory alone. Although panic alarm pendants and panic buttons are available in vulnerable areas throughout the building, they do not distribute the information effectively. Forensic Services would like to purchase a basic Lynx duress and emergency notification system that is compatible and interacts with the City's current C-Cure safety and security systems already in place.

The Lynx emergency notification system has the ability to send notifications to a wide range of recipients simultaneously. Lynx uses physical duress buttons, virtual duress buttons, or triggers from other devices resulting in mass notifications via cellular phone calls, LED signs, audible alerts and pop up messages on workstation monitors

An evaluation team reviewed the four responses from Tyco, Enterprise Security, APL Access and Alertus. Alertus was deemed as non-responsive for providing products that do not meet the requirements. The response with the lowest pricing was submitted by Tyco. Tyco has performed work at City facilities in the past. The City has been satisfied with the vendor's performance.

Alternatives

Council may choose not to authorize the purchase and new responses will be solicited.

Fiscal Impact

The initial purchase of \$38,000.00 is available through Arizona Criminal Justice Commission Grant Funds (\$23,986) and the remaining balance in the Police Department operating budget (\$14,014). The Arizona Criminal Justice Commission Grant Funds will expire December 31, 2016. If the purchase is postponed or denied, there is the potential loss of funding.

The Police Department has requested an annual contract amount of \$100,000 to allow for the initial purchase by their Department and the remaining capacity will be available for future projects within the Police Department and throughout the City.
